K.K. SOULTANOV. The self-sufficiency of diversity, or a dialogue of differences? (A Search for a new model of cultural interaction). The Soviet-period crisis of national and cultural identity was transformed into a crisis of intercultural communication of the post-Soviet era. The concept of 'unity in diversity' that has long been present in the world discourse of humanities was pushed into periphery of scholarly interests as a hostage of the ideological connotations of the past. In the practice of literary studies the widening semantic gap between ethno-cultural and communicative approaches led to the narrowing of the analysis of multi-dimensional semantics of a work of fiction. The change of social and political contexts and the growing methodological demand for the full description of cultural and literary dynamics require the rediscovery of the principle of dialogical interaction in the current conditions of the post-Soviet cultural diversification. The author concludes that it is necessary to problematize intercultural dialogue as a resource of self-identification and a generator of new meanings. It is argued that the idea of dialogism does not need to be postulated as an axiom once again but rather requires an innovative impulse within a particular literary, historical and cultural context.

A.A. PAVLOV. Roman concepts of the tribunate of the plebs: M. Terentius Varro. The Roman institution of the tribunes of the plebs that was turned into a concept of the tribunate of the plebs by the political philosophy of the Enlightenment and the Modern period had been discussed already by Roman historians of the 1st century BC. who formulated a number of related theories. One of them is to be found in the works by a Roman antiquary and grammarian Mark Terentius Varro who saw the tribunate of the plebs as a structural part of magistracy, although the lowest one from the point of view of the *honores*, whose function was to protect the plebs. *Keywords: tribunate of the plebs, Roman antiquarian historiography, M. The ability to defy death, in Seneca's opinion, was another indispensable condition that enabled a society to move forward. I.I. The object of study is the relationship 'teacher – pupil' as the most marginal one for the European culture of the pre-industrial period since it could demonstrate the ultimate use of the vitalist discourse inserted into a number of hierarchies including religious, political, social and gender ones.
